



More ways to extend your support to CAm, both now and in the future.

We recognize that with the constantly changing COVID-19 situation around the world, this is an unprecedented time for everyone. Our hearts and thoughts go out to each and every one of you. Yet in times like these, we believe it is still important to provide you with useful information about how you can help ensure Cambridge's mission continues in the future. Along with gifts made directly by credit card or check, here are some additional ways you can support Colleges and/or the University:

1. Give through your Donor-Advised Fund (DAF)

If you have a DAF, you can recommend the fund directs a gift to CAm—it's simple and tax-effective!

2. Make a gift from your Individual Retirement Account (IRA)

If you are 70½ years old or older, you can make a Qualified Charitable Distribution (QCD) of up to \$100,000 per year from your IRA directly to CAm, without having to pay income taxes on the money.

Note: The Required Minimum Distribution requirement has been waived for 2020, per the CARES Act (Coronavirus Aid, Relief, and Economic Security Act) signed into law on March 27, 2020, however you can still make a QCD. Find out more about the CARES Act here: www.cantab.org/CARES
