Under the CARES Act, all taxpayers are eligible to deduct up to \$300 of their charitable giving, whether you itemize deductions or take the standard deduction. This is \$300 you won't have to pay taxes on, even if you don't itemize. And, if your employer matches charitable contributions, your gift to CU could make an even bigger impact!

At CU, we remain grateful for all those who ask, "How can I help?" If you can, I encourage you to take advantage of the CARES Act tax benefits by making a gift to CU today, either by mail below or online at giving.cu.edu/cugives.
