CHOOSE YOUR LEVEL

The Leadership Circle honors contributors who make cumulative gifts of \$1,000 and above during the University's fiscal year, which runs September 1 through August 31. Matching gifts from companies and firms count toward membership.*

NULC members can choose from the following levels of giving, each offering a variety of benefits:**

RECENT UNDERGRADUATE ALUMNI

Undergraduate alumni who graduated within the last nine years can take advantage of special giving rates to join the Leadership Circle, gaining access to a powerful network of Northwestern supporters. Recent alumni receive benefits at the Member level

MEMBER - \$1,000/YEAR

Access to the NULC Insider Series, exclusive interviews with University leaders and faculty innovators who will answer your questions about Northwestern; stories about the difference your philanthropy makes in the NULC impact report; and campus news and updates in *Inside the Circle*, our email newsletter. FELLOW - \$2.500/YEAR

All Member benefits plus special communications from the president and trustees, and two one-day campus parking permits by request.

SUSTAINER - \$5,000/YEAR

All Fellow benefits plus access to an NULC donor liaison who can answer questions about Northwestern and your giving, networking opportunities with other NULC members, and five one-day campus parking permits by request.

DEANS' CIRCLE - \$10,000/YEAR

All Sustainer benefits plus special access to Evanston and Chicago campus facilities and programming, including behind-the-scenes tours at venues such as The Block Museum of Art and Deering Library.

PRESIDENT'S CIRCLE - \$25,000/YEAR

All Deans' Circle benefits plus opportunities to attend events with University leaders.

FOUNDERS' CIRCLE - \$50.000/YEAR

All President's Circle benefits plus personal VIP assistance and private campus tours of new buildings and special exhibits.

Most NULC members also belong to NU Loyal, which recognizes donors who give to Northwestern for three or more consecutive fiscal years. The generosity and commitment of NULC and NU Loyal members help advance the University's highest priorities.

Leadership gifts made during your reunion year count toward your reunion class gift.

^{*}Matching gift claims count toward membership regardless of when actual corporate funds are received. Claims must be received in the same fiscal year as the originating gift to count toward membership.

^{**}Per IRS regulations, gifts from donor-advised funds or foundations may not be eligible for all NULC benefits. Please call the NULC office at 847-467-2384 with specific questions about benefits and tax deductibility.
