# Dawood Farahi, Ph.D. – A President for the Ages

## *A Look Back on 17 Years of Presidential Service to Kean University*

“It would be untrue to say I will not miss serving as president of Kean University, because I will. I will miss the students. I will miss the chance to do more... Thank you all!”

Dawood Farahi, Ph.D. proudly served as President of Kean University for nearly two decades. His service concluded, as he had previously announced, in June 2020, in the middle of a challenging time for not only the University but the world at large – a global pandemic. However, COVID-19 was not the only challenge Farahi saw during his tenure, yet he was always prepared with a plan to overcome challenges and position the University to arise from them better than before. He seized opportunities as they arose and always fought to reimagine Kean as the best among its peers.

The mission of access and quality has defined Kean University over the years, and Farahi dedicated himself to these objectives. In fact, he has said it was this very mission that drew him to the role in 2003. He spent the first years of his tenure consulting with faculty, staff, students, alumni, legislative and community leaders, donors, supporters, and members of the Board of Trustees – immersing himself in the culture of the University and understanding how to strategically address growth. He worked with stakeholders to outline a vision rooted in the University’s mission, with

the diversity of Kean students, and their commitment, desire, and zeal for success, at the core of every decision made to improve the look and feel of the campus, the quality of programs offered, and the facilities in which world-class educations would be delivered by world-class faculty.

Farahi was a visionary. He began carrying out this vision by creating walkways, pedestrian bridges, and landscaping projects in order to make every student, faculty member, and visitor’s journey around campus a beautiful one. In addition, many important buildings were either renovated or built from the ground up, adding to the prestige of the campus. The addition of the Liberty Hall Museum and its surrounding acreage made Kean the guardian of a national historical treasure, replete with one-of-a-kind documents dating back to the American Revolution. This purchase connected Kean’s Main and East campuses via a trolley bridge overlooking the Elizabeth River, cutting travel time between the two campuses.

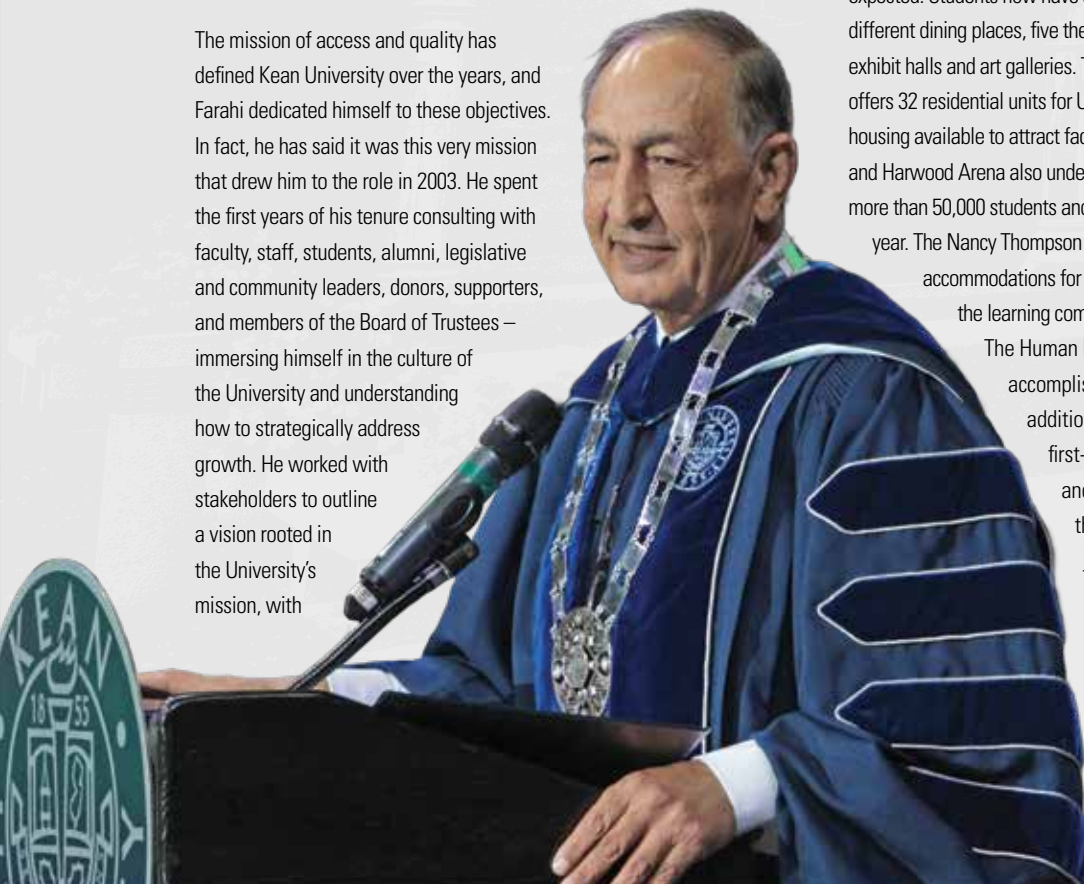
He strategically focused on improving academic programs, expanding residential facilities, and creating athletic buildings with a goal of becoming a regional university with all the amenities and experiences students expected. Students now have access to three new residence halls, seven different dining places, five theaters, and large auditoriums, as well as five exhibit halls and art galleries. The new Hynes Hall campus housing village offers 32 residential units for University employees making affordable housing available to attract faculty scholars. The Miron Student Center and Harwood Arena also underwent huge renovation projects. Today, more than 50,000 students and community members visit Kean each

year. The Nancy Thompson Library became a learning commons with accommodations for the way students work today. In front of the learning commons lies one of Farahi’s favorite facilities:

The Human Rights Institute, one of his proudest accomplishments from his time at Kean. These additions and expansions have made Kean a first-choice destination not only for current and prospective students and faculty but for thousands of enthusiastic visitors.

The premier educational programs that Farahi brought to Kean have significantly enhanced the University’s reputation.

When he first became president, there





were only four master's programs and no doctoral programs. The Nathan Weiss Graduate College now offers six doctoral degree programs and more than 70 options for graduate study leading to master's degrees, professional diplomas, or certifications. Many of these programs are ranked the best in the state and others are competitive nationally. The University's six undergraduate colleges now offer more than 50 undergraduate degrees over a full range of academic subjects.

In 2005, he launched the New Jersey Center for Science, Technology and Mathematics (NJCSTM), which was the first program of its kind in the state. With programs in STEM fields, biotechnology, biomedicine, and life sciences entrepreneurship, this center is a flagship for research, programmatic quality, and innovation.

Kean's design program is now a beacon of innovation and creativity, while the public architecture program is one of the best in the country. Tutorial and career development services are offered for all students. Farahi led an initiative to diversify locations for instruction and put a strong online education program in place in addition to the Toms River, Ocean County, and New Jersey Skylands regional campuses, as well as Wenzhou-Kean University in China. More than a dozen new programs have been added to the Kean curriculum since 2003 and more than 500 teacher-scholars were added to the faculty ranks during Farahi's time as president.



Farahi's *Vision 2020 Strategic Plan*, developed in collaboration with the University Planning Council, is now complete. *Vision 2020* was an aggressive seven-year plan to enhance Kean's world-class programming, build additional state-of-the-art facilities, develop programs that help our students better succeed and thrive in our increasingly diverse and technologically advanced environment, and improve the quality of instruction and research capabilities for our faculty. For nearly a decade, Kean has been the most affordable, comprehensive University in the state of New Jersey.

The number of scholarships available through the University and the Foundation have increased ninefold during Farahi's tenure, with two recently-added scholarships providing for over 300 students.

A dozen years ago, the financial crisis of 2008-2009, the Middle States probation, and consequences from superstorm Sandy forced Farahi and the University to assess who Kean was and where the University was headed. He determined Kean had to redefine itself by creating a vision to become more competitive, more innovative, more efficient, more student-centered, and accountable to the mission of the institution. He knew that Kean needed to change and reimagine itself to become a great university. Today, Kean is a stronger, more robust, and competitive university, and it is Farahi, and all his forethought and grand vision, who is to thank for these illustrious accomplishments.



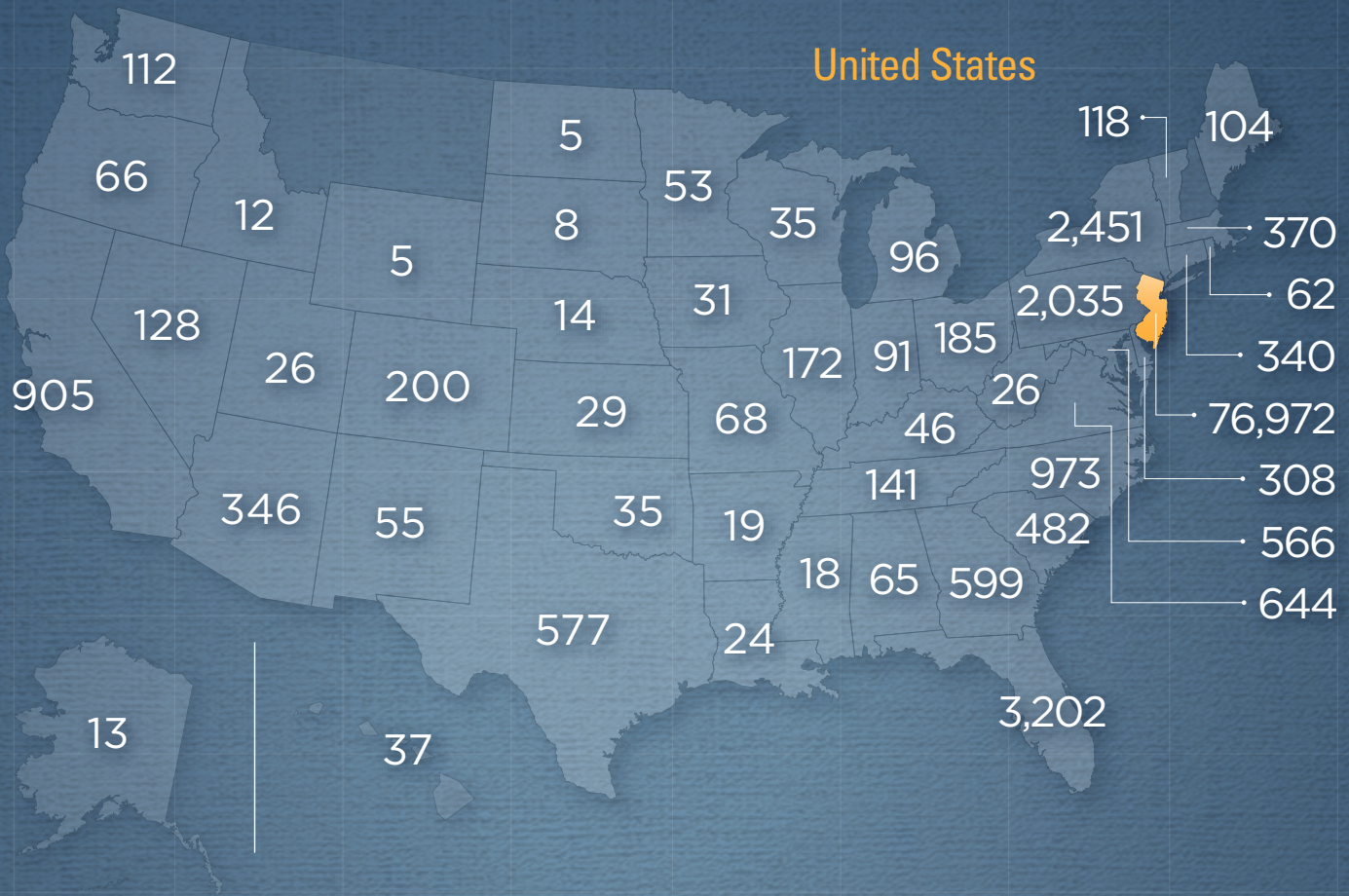

## Profile: Kean's New President, Lamont O. Repollet, Ed.D.

**Lamont O. Repollet, Ed.D.**, the New Jersey Commissioner of Education and a Kean alumnus, will become the 18th leader of Kean University.

The Board of Trustees announced the appointment on Monday, May 11, 2020 following a unanimous vote in support of the thoughtful and charismatic educator.

"Dr. Repollet will step into the presidency with confidence and experience, and with the strength needed to lead Kean forward on its path of access and excellence," said Board Chair Ada Morell '97. "At such a critical time in the University and the state's history, he brings both stability and ingenuity. He knows our mission. He lives our mission, and he is committed to ensuring that Kean provides the world-class education and experiences that students demand."

Repollet, who currently oversees the top-ranked public school system in the nation, this summer will succeed President Dawood Farahi, Ph.D., who is stepping down from the position at the end of June after 17 years of transformative leadership.

"I am both humbled and energized by this appointment, and by the faith the Board of Trustees has placed in me to continue Kean University's progress as one of the best institutions of higher education in New Jersey," Repollet said after the vote. "I have important work to finish with the state, but I am grateful Governor Murphy supports this next step in my career, and I look forward to working with him in this new role."

Repollet says he supports Governor Murphy's student-centered vision for higher education with the goal of making New Jersey the hub for American innovation and economic opportunity. Included in the vision is a Student Bill of Rights to encourage students to pursue higher education through college preparatory programs, reduce college costs, support a timely path to graduation, create a welcoming learning environment, and cultivate research, innovation, and talent.

Repollet served as the state's education commissioner since 2018. During his time as commissioner, New Jersey was ranked best in the nation in the Education Week Quality Counts 2019 report. He and his team worked to expand early childhood education, promote a school culture that embraces social and emotional learning, and strengthen STEM opportunities for students. He made outreach to stakeholders across the state's public education system a key component of his leadership style. Most recently, he worked closely with Governor Murphy as New Jersey's public school children shifted to remote education amid the COVID-19 pandemic.

From 2014 to 2018, Repollet served as superintendent of the Asbury Park School District, where he implemented a number of programs that helped increase the graduation rate by 30 percent. Earlier in his career, he served as a high school principal and teacher.

Repollet graduated from Kean with a master's in educational administration in 2000 and served on the Kean Board of Trustees from 2011 to 2018. In addition to his Kean master's degree, Repollet earned his Bachelor of Arts in communication from The College of New Jersey and a Doctorate in Education from Nova Southeastern University.

"Lamont really impressed the search committee from day one," Steve Fastook H'06, Chair of the Kean University Foundation Board of Directors said. "Some of us knew him from his days on the Board, some did not, but all of us were impressed with his depth of knowledge of the academic and economic challenges ahead. He has a strategic vision for moving students past the K-12 pipeline into a K-bachelor's pipeline that will define our future."

Repollet will take the helm of a University with more than 16,000 students in Union, Toms River, Manahawkin, and Jefferson Township, New Jersey as well as Kean Online and at Wenzhou-Kean University in Wenzhou, China.





## Faculty Spotlight



**Jin Wang, Ph.D.**, an experienced business education leader, was named the new dean of the Kean University College of Business and Public Management as it prepares for a new era of growth and a move to a state-of-the-art building, Hynes Hall, set to open in 2020.

A Fulbright Scholar, Wang came to Kean from Drury University in Springfield, Missouri, where he served as dean of the Breech School of Business Administration and Economics. He has a depth of experience in enrollment growth, academic program development, and program accreditation.

"I truly find this opportunity inspiring," Wang said, noting that he was drawn to the connection with Wenzhou-Kean University. "I was deeply impressed with the vision of this University and the mission to provide a world-class education to a very diverse population of students. This is an exciting place and an exciting time. I feel I can make a difference here."

At Drury University, Wang created new international cooperation opportunities for the school, worked with the business community on curriculum improvement and program development, played an active role in fundraising for a new building, and worked with faculty and administration to create a new major and grow enrollment.

Prior to that, he was dean of the College of Business and Economics at American University of Kuwait, dean of the Bill and Vieve Gore School of Business at Westminster College in Utah, and associate provost and dean of academic services at the University of Tampa. He also served as associate dean of the Liberal Arts and Sciences at Rowan University and University of Wisconsin-Stevens Point. Wang has published extensively on socioeconomics, entrepreneurship education, and international business and trade destinations for top business students who want a rigorous curriculum taught by the best faculty. Suzanne Bousquet, Ph.D., Vice President of Academic Affairs at Kean, said, "We are so thrilled to have someone with his experience in this role."

Wang said his immediate priorities are to hire top faculty and lead the college through the accreditation process. He will also focus on enrollment growth and retention, and on moving the college into its new building, Hynes Hall, next year.

"It is very important for students to have an inviting, encouraging, and stimulating learning environment," he said. "This building will help our college create synergy around the programs we have, will make faculty interaction very efficient, and will help promote interdisciplinary research and entrepreneurial ideas."

Wang earned his B.A. in economics at Zhongshan University in China, his M.A. in economics from Ohio University, and his Ph.D. in economics from Kansas State University.



**Barbara R. Ridener, Ph.D.**, an educator who began her career in an elementary school classroom and rose to become a top academic leader at Florida Atlantic University, was named the new dean of the College of Education at Kean University.

"This felt like the right position and a good fit for me," Ridener said. "I see the opportunity to be creative. Education has long been a field where people feel they should do things as they've always done; but, what sets a program apart is the fulfillment of the needs of the students it serves. As the population and the demand change, we have to make sure we change too."

"I would like to create programs that attract new students, provide new opportunities, and partner with local school districts and employers to be sure we're offering programs that address their needs," Ridener said.

Suzanne Bousquet, Ph.D., Vice President of Academic Affairs at Kean, said Ridener was selected for her comprehensive experience and leadership ability.

"Kean has been known as a leader in teacher education across the country for decades and we are thrilled to have Dr. Ridener on board to shepherd the college into the future," Bousquet said. "We look forward to continuing our legacy of excellence in education."

Ridener served as chair of the Department of Teaching and Learning at the Florida Atlantic University College of Education, working her way up from the position of assistant professor. She began her career as an elementary teacher focusing on mathematics.

She earned her bachelor's and master's degrees in education from the University of Central Florida, and her Ph.D. in Mathematics Education from the University of Georgia. She has also conducted research and published extensively.

Ridener, who has advocated for diversity and equity throughout her career, said she is pleased to have the opportunity to work with Kean's diverse student body.

"We see students of every background, nationality, and ethnicity, and we all come together and learn together," she said. "That diversity makes for very positive outcomes. In education, it's critical to identify where students are when they come in and take them to where they need to be."

# The Kean Community's Response to the COVID-19 Pandemic

## Supporting Students

Kean's Office of Career Services has taken great strides toward helping students prepare for success in the job market amid the challenges caused by the COVID-19 pandemic.

As classes swiftly shifted to a remote delivery method in the spring of 2020, so too did services that students rely on for career planning and academic support. Career Services staff immediately began providing assistance remotely, including resume writing and reviews, mock interviews, and career advice, as well as job and internship searches. The office also developed digital presentations on remote internships, online interviews, and other career tips for the changed economic environment. Additionally, a new presence on LinkedIn is helping students stay connected and grow their networks virtually.

As employers continue to navigate remote working environments during COVID-19, students at Kean University can demonstrate their potential to become valuable contributors due to the fact that they themselves are currently navigating learning in a remote environment. The resilience and flexibility Kean University students have gained in 2020 translates to exceptional preparedness in facing the job market during this ever-changing time.

## Hosting a COVID-19 Testing Site

In March 2020, Union County Manager Ed Oatman '98, a member of the Kean University Board of Trustees, knew the county needed to make COVID-19 testing available for its 550,000 residents as quickly as possible. While the state was setting up large facilities in North and Central New Jersey, Oatman was looking to create, open, and manage a testing site closer to home.

Since the University had shifted students to remote learning, it became the perfect space for a COVID-19 testing site—large, central, and easy to navigate. The University was more than happy to provide the space and services needed to help combat COVID-19, taking its role in protecting the health and safety of the surrounding community seriously.

Union County officials arrived on the Union Township campus and transformed the massive Vaughn Eames parking lot into a free COVID-19 testing site for Union County residents and first responders. The testing site opened for business on Monday, March 23, 2020 and served more than 700 residents by Friday of the same week. Those numbers doubled in the weeks to come, and the site expanded to six days a week to handle the demand.



On site, county employees, healthcare professionals, and volunteers all worked tirelessly to ensure health and safety was the top priority. Those seeking COVID-19 tests were required to arrive by car and remain in the car. By the end of May, the testing site had administered more than 22,000 swabs, about 90% of them for residents of Union County. The Union County facility is being run by the county through a partnership with Overlook Medical Center (Atlantic Health System) in Summit, Trinitas Regional Medical Center in Elizabeth, and Robert Wood Johnson University Hospital (RWJ Barnabas Health) in Rahway. Oatman credits the Union County Board of Freeholders, area legislators, the Office of the Governor, the state Department of Health, and Kean University with transforming the idea for the testing site into a reality. About 85 people make up the workforce at the testing site, including volunteers, National Guard, and county employees.

#### **Kean-Based Companies Contribute to COVID-19 Research**

Two companies based in Kean University's STEM Building are part of global efforts to develop COVID-19 tests and treatments. MDSeq Inc. and Eton Bioscience New Jersey are both part of the nonprofit Institute of Life Science Entrepreneurship (ILSE) at Kean University. ILSE is a life science technology accelerator, providing research and business support to entrepreneurs and academic and biomedical institutions.

MDSeq, in collaboration with New York University scientists, is working on a next generation COVID-19 test, with the goal of increasing the testing capacity of a diagnostic laboratory by 50- to 100-fold. The "high-throughput" method analyzes saliva to detect the RNA (ribonucleic acid) genome of the novel coronavirus that causes the disease. "We would like to contribute to making available the new generation of diagnostic tests that will have sufficient scale and sufficient sensitivity to change the entire dynamic of the battle against COVID-19," said Dmitri Rebatchouk, Ph.D., CEO of MDSeq.

When perfected, Rebatchouk sees the MDSeq test being used in large-scale settings, such as community-wide testing, at companies or organizations testing their entire staff, or at entry points – testing every passenger arriving in an airport, for example. The goal would be to detect the virus before the infected person is symptomatic and becomes contagious.

At Eton Bioscience New Jersey, researchers are providing the company's clients, including the Columbia University Vagelos College of Physicians and Surgeons, the Icahn School of Medicine at Mount Sinai, and Memorial Sloan Kettering Cancer Center, with DNA (deoxyribonucleic acid) sequencing and PCR (polymerase chain reaction) primer synthesis, which studies short DNA fragments, in support of their efforts to develop COVID-19 tests and treatments. "You can think of it as the first few bricks for a building," said Henry Geng, branch manager of Eton Bioscience New Jersey. "By providing high quality and timely services, we hope to speed up COVID-19 research and contribute to future breakthroughs." Eton Bioscience is seeking regulatory permission to assist in coronavirus research more directly, including supporting test kit manufacturers and university testing labs.

#### **Amid COVID-19 Illness and Loss, Kean Student Graduates with Honors**

There have been many stories of heroes and heroics since the COVID-19 outbreak, and Kean's Daniela Derius-Rodriguez is now one of them. Derius-Rodriguez lost her mother and grandfather to COVID-19 in April and March 2020, respectively, and suffered mild symptoms from the illness herself. But the Kean senior pushed through sorrow and her own bout with the illness to graduate summa cum laude in May, just as her mother would have wanted. "It was a goal of mine and my mother for me to graduate summa cum laude. She was really proud of me," Derius-Rodriguez said. "When she passed away, I was not going to let her down. I had a goal to finish my last semester strong, and I did just that. I wanted to make her proud." Derius-Rodriguez's mother, Maria Rodriguez-Derius, was also a Kean graduate, earning her bachelor's degree in bilingual elementary education in 1997.

Daniela currently works as a communication and marketing assistant. "Daniela was an exemplary student who also took on leadership roles in Kean's Public Relations Student Society of America chapter," said Jeremiah Sullivan, executive director of the School of Communication, Media and Journalism. "She radiates tenacity, determination, and grace with everything she does. I am confident that no matter what she chooses to do going forward, she'll do so with spirit and success."

### **Kean Receives Historic Gift from Retired Professor**

Distinguished Professor Emerita Dorothy Grant Hennings, Ed.D. 'H10 recently made a historic gift to Kean University, where she and her late husband taught for a combined 63 years.

The gift, which is the largest in the University's history, will fund a scholarship named in honor of biology Professor Emeritus George Hennings, Ed.D. 'H10 that will support students pursuing degrees in science and science education, as well as the Centennial Fund Opportunity Scholarship that is open to high-achieving, low-income students from all majors.

In recognition of the generous donation, Kean's science college will be renamed The Dorothy and George Hennings College of Science, Mathematics and Technology, Kean's Science Building will be renamed George Hennings Hall, and Room 128 in that building will have signage noting it was George Hennings' office when he worked at Kean. In addition, the new wing of the science building currently under construction will be named George Hennings Research Wing.

Also, as a result of the historic gift, the education building, currently called Hennings Hall, will be renamed Dorothy Grant Hennings Hall. In a tribute to the devotion that Dorothy and George Hennings had to each other and to Kean, the walkway that connects the renamed buildings will be named Dorothy and George Way.

"Dorothy and George Hennings had a passion for education and a commitment to excellence," said Kean President Dawood Farahi, Ph.D. "We are profoundly grateful that they chose to dedicate their tremendous gifts, energies, and talents to Kean and its students. This gift will be used to build on their already significant legacy, and all of us at Kean thank Dorothy for it."

The Hennings received honorary degrees from Kean in 2010 and were awarded Kean's William Livingston Award in 2013 for their contributions to the promotion of excellence in education, solid business values, and outstanding public service to enhance and build a better society. George Hennings died in September 2016, and Dorothy has continued their support for Kean.

"Generations of students will benefit from their unwavering philanthropy."

George and Dorothy Hennings met at Kean in 1965 and were married three years later. They were partners in everything, sharing a dedication to the development of skilled teachers and, in their personal lives, a love of travel and charitable giving. Through it all, they were connected to Kean, a place that Dorothy once said "we call our own."

At its meeting on March 9, 2020, the Kean Board of Trustees approved a resolution thanking Dorothy Hennings and renaming the buildings. Hennings was there and offered her own thanks for the honor given to her late husband.

"It's the best birthday present that you are giving me," she told the Board of Trustees, days before her 85th birthday.

After they retired from Kean, the Hennings traveled the world — visiting all seven continents together among many other adventures — and always took Kean along with them. Wherever they went, they took a photo holding a Kean University tote bag and would always promote the University to their fellow travelers.

"Dorothy and George Hennings represent the best of Kean," said George Chang, Ph.D., dean of The Dorothy and George Hennings College of

Science, Mathematics and Technology. "It is my hope that this donation helps support students who are similarly engaged in learning and helping others. It is a phenomenal gift."

At Kean, Dorothy Grant Hennings taught in the Department of Instruction, Curriculum and Administration from 1965 until she retired in 2001. George Hennings taught in the Department of Biology from 1960 until his retirement in 1987. The couple authored two books together: *Keep Earth Clean, Blue and Green* (MacMillan, 1977) and *Today's Elementary Social Studies* (HarperCollins, 1989). They also served as members of the Kean University Foundation Board of Directors.

### The New Home for History

*Liberty Hall Academic Center is the new center for history at Kean University*

Located right next to the Liberty Hall Museum is one of the newer installments to Kean University: Liberty Hall Academic Center. The facility is the new home for Kean's Department of History on campus.

Built over the summer of 2019, the research centers, archives, exhibits, and classrooms can now be utilized by students and faculty studying history. Elizabeth Hyde, Ph.D., chair for the Department of History, says the space is exactly what the history department needed.

"[The building] is the realization of a concept that we've developed in the last two to three years, to provide the setting for the kind of teaching that we do here in the history department," Hyde said. "We encourage our undergraduate students to do original, primary source research in their courses."

A feature of the building that distinguishes Kean's history department from most undergraduate history programs in the state is that Liberty Hall incorporates the academic, classroom space with archival space, where undergraduates can get a first-hand look at the primary resources available to them.

"Students are getting to explore 18th, 19th, and 20th century documents as they are learning about the past," said Hyde. "[Students are] learning how to do critical thinking and analysis of a data set in historical documents to figure out what they can teach us about the past, and this building allows us to do that."

Additionally, a gallery exhibition space is located on the first floor of



the building. The inaugural exhibit displayed was *Life, Liberty, and the Pursuit of Happiness*, which explored the founding of the nation, Kean University, and Liberty Hall. It used documents from Liberty Hall Museum, the Kean University archives, and even the New Jersey state archives.

"The exhibitions will be rotating," said Hyde, "but this was the inaugural exhibit for the opening of the building."

The space is a means for both students and museum spectators to take advantage of accessible exhibits and historical artifacts. In this way, students and the community can find themselves surrounded by the histories of the Kean and Livingston families, who lived in what is now Kean's Liberty Hall Museum.

Before Liberty Hall Academic Center was built, the Department of History used to be in Willis Hall, which is no longer a building on campus. After that, Townsend Hall housed the Department of History before the department finally relocated to Liberty Hall Academic Center.

"What really is special about the building is that we can combine the archives with the classroom space in a historic location," said Hyde.

### ***Da Vinci – Inventions Exhibit at Kean University***

The Liberty Hall Academic Center at Kean University unveiled a world-class traveling exhibition, *Da Vinci – Inventions*, showcasing faithful reproductions of many of Renaissance artist Leonardo da Vinci's most important inventions, drawings, paintings, and more.

The exhibition opened to the public on January 25, 2020, bringing history to life in the University's newest academic building at the historic site of Liberty Hall, home to New Jersey's first elected governor William Livingston, in Union, New Jersey.

*Da Vinci – Inventions* explores the artist's life, creativity, and complexity. Visitors experienced more than 60 of da Vinci's inventions, many recreated in full-scale. A tank, submarine, helicopter, and more were displayed across 6,000 square feet of exhibition space.

"This kind of world-class exhibition on one of history's greatest thinkers is exactly the kind of program we envisioned bringing to our students and community members when we opened the Liberty Hall Academic Center this past fall," said Kean President Dawood Farahi, Ph.D. "We are looking forward to welcoming visitors so they can experience history and art in a new way."

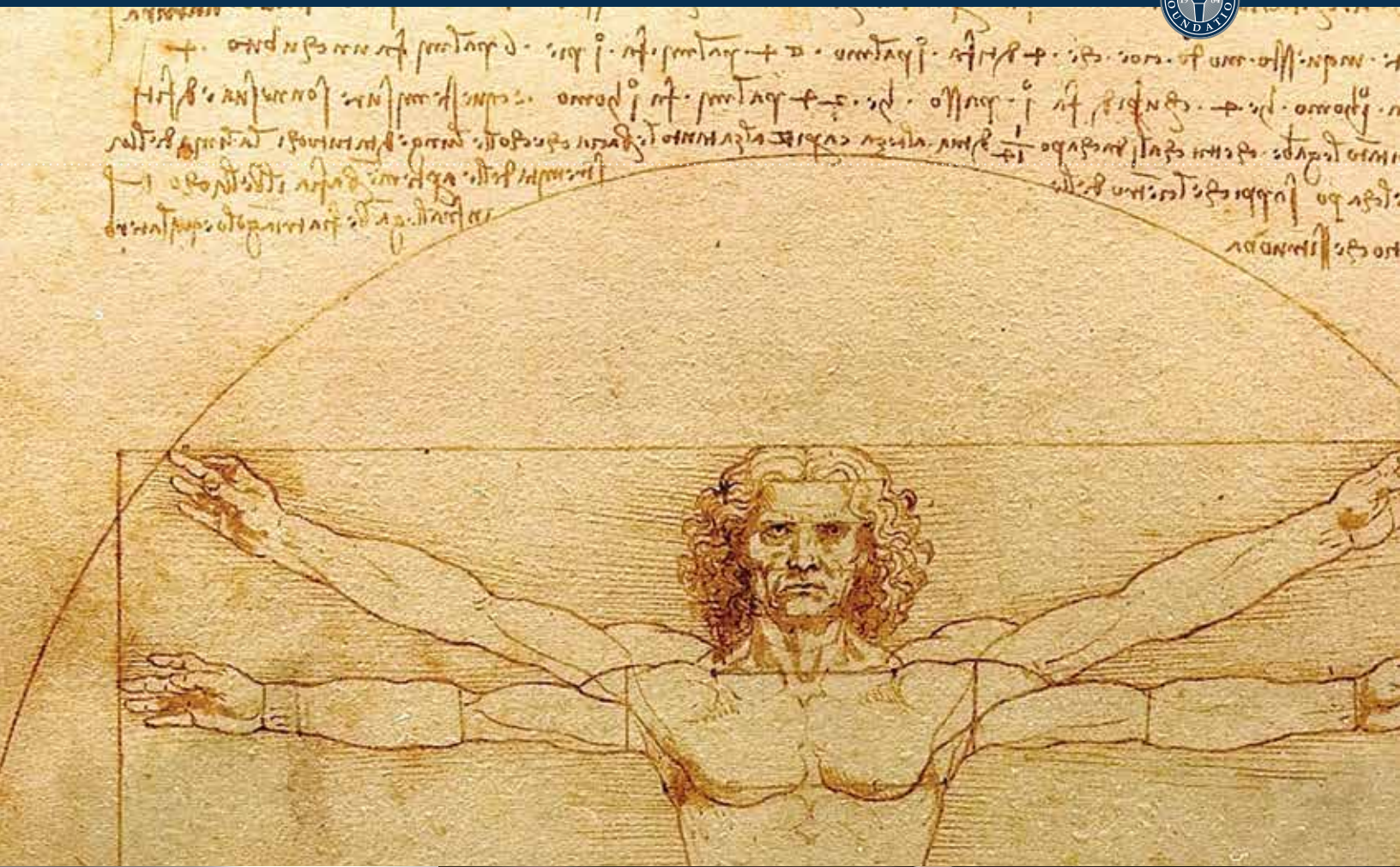
The exhibition examined da Vinci's sketches, paintings, and the machines he invented on paper, and invited visitors to interact with them, allowing them to explore his genius and creations in their own way. Guests also enjoyed recreations of the Mona Lisa and The Last Supper in superb detail.

The exhibition was created by Grande Exhibitions and has appeared around the world, including in Italy, Sweden, Germany, the United Kingdom, and the Philippines.

All of the inventions brought to life for the exhibit were crafted by Italian artisans, many using techniques and materials from the Renaissance period. Scouring more than 6,000 pages from da Vinci's personal codices (notebooks), the artisans deciphered hidden clues, intentional mistakes, and mirror-image writing that he employed to keep his works top secret.

Lynette Zimmerman, executive director of Liberty Hall Academic Center, said visitors can connect the historical perspective that comes from such exhibits to current global issues and learn from that experience.

"The purpose of this new facility at Kean University is to be a support framework that connects and engages the community with transformative culture," Zimmerman said. "*Da Vinci – Inventions* embodies that mission. It will inspire students and the public alike to promote equality and social mobility through education."

### **Liberty Hall 360: Revolutionary Wedding**

Witness a project 244 years in the making, conceived and produced by Kean University students with the support of faculty, staff, alumni, and neighbors. The film invites audiences to attend the wedding of future Founding Father John Jay to socialite Sarah Livingston, the daughter of the first elected governor of New Jersey. A colorful cast of characters leads the audience on an adventure around the mansion and grounds as they experience the story through the eyes of “Lucius Horatio,” a rambunctious young guest at the wedding.

Two versions of this film were created to give audiences and Liberty Hall museum-goers the exciting experience of feeling like they were actually there on this historic occasion.

The widescreen version was filmed with wide-angle lenses and in first-person perspective to put the audience in Lucius’ shoes, while the 360° virtual reality (VR) version takes that experience to the next level. Using VR headsets, audiences are transported into a fully immersive environment with the sights and sounds of the day all around them. It is not just a movie – it’s a time machine.

*Liberty Hall 360: Revolutionary Wedding* was created through the collaboration of students, faculty, staff, and alumni of Kean University across multiple disciplines including graphic design, history, communication, writing, and theatre.

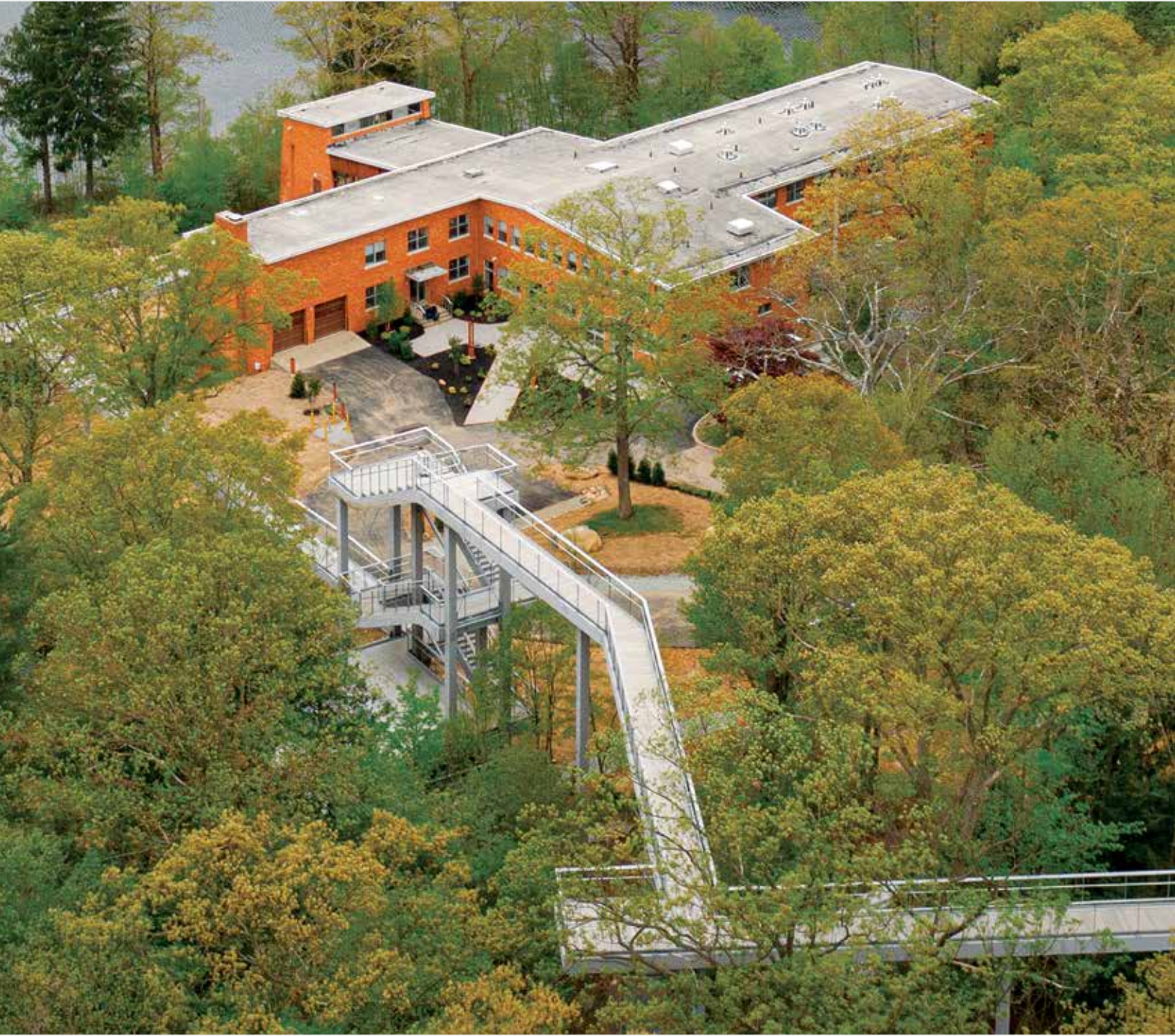
Conveniently located near County College of Morris, Sussex County Community College, and Passaic County Community College, Kean Skylands is committed to helping area residents make a smooth transition toward earning their bachelor's degrees while remaining close to home.

The campus is like no other in New Jersey. The University renovated a 30,000-square-foot former abbey to serve as the campus' main building. The Lodge now includes nine classrooms, a gym, 24 residential rooms, and flexible space for events. The Cabin, the campus' newest building, is nestled among the trees and offers impressive views of the area with its floor-to-ceiling windows. The Cabin has three levels of classroom space and an open observation deck crowning the building. Workers also built an elevated, three-level skywalk that includes two outdoor classrooms and event space to facilitate programming.

Students enrolled at Kean Skylands benefit from Kean's low-cost tuition rates and financial aid, as well as the University's learning support, tutoring, and career services.

### **Kean Alumnus Coaches Team in Little League World Series**

Kean graduate Jairo Labrador '07 coached the Elmora Troopers of Elizabeth, NJ in the Little League World Series. The Troopers represented the Mid-Atlantic region and were one of the final four teams in the United States bracket.

### **Human Rights Institute Exhibition: Art Illuminates Ireland's Great Hunger**

Ireland's Great Famine (1845-1849), in which an estimated one million people in Ireland died of hunger and another one million emigrated from the country, was the subject of an exhibition at the Human Rights Institute Gallery at Kean University.

The art featured in *Tragedy & Tribute: Art Illuminates Ireland's Great Hunger* was on loan from Ireland's Great Hunger Museum at Quinnipiac University. The works were created by eminent Irish and Irish-American artists of the last two centuries.



"The experience of Irish immigrants parallels that of refugees coming to the United States today," said Laretta Farrell, D.Litt., director of the Human Rights Institute at Kean University. "This exhibition helps inform us about the kinds of circumstances that drive people around the world to seek refuge in the United States."

### **Kean Receives National Science Foundation Grant to Cultivate Sustainable Agriculture**

Kean researchers received a grant from the National Science Foundation for a sustainability study that helps to develop alternative, more sustainable methods of cultivating fresh vegetables for consumers.

The \$170,000 grant will fund a two-year Life Cycle Assessment that will compare and analyze aquaponic and hydroponic vegetable production, two alternative water-based growing techniques, at facilities on three New Jersey commercial farms. The team is led by Assistant Professor Dongyan Mu, Ph.D., and Executive Director Daniela Shebitz, Ph.D., both of the School of Environmental and Sustainability Sciences. Three Kean students will be hired to work as part of the research team.

### **Kean Architecture Student Designs Kean University Learning Plaza**

Located at the former site of Willis Hall, the Learning Plaza is now being enjoyed by students, faculty, and staff alike.*







### **The Institute for Life Science Entrepreneurship at Kean Named Top Tech Accelerator in the Nation**

The Institute for Life Science Entrepreneurship (ILSE) at Kean University received the Best Life Science Tech Accelerator-USA award from Global Health & Pharma, which “pays homage to those whose innovative work within the pharmaceutical industry contributes towards furthering the advancement of patient care.”

### **Kean Professors Travel the Globe as Fulbright Specialists**

Two Kean history professors took their academic expertise overseas as Fulbright Specialists at universities in China and New Zealand.

Xurong Kong, Ph.D., assistant professor of Chinese literature and civilization, was an expert consultant at Sichuan University in Chengdu, China, and Christopher Bellitto, Ph.D., professor of history, filled a similar role at the University of Canterbury in Christchurch, New Zealand.

Both spent time teaching, researching, traveling, conducting workshops, and meeting with students, other scholars, and faculty at their host institutions and other local universities.



### **Kean Seniors Achieve Marketing Success and National Recognition**

Two Kean University marketing majors were named among the top marketing students in the country as Marketing EDGE Collegiate Summit Scholars.

Jessie Coronel of Clifton and Dhruva Patel of South Brunswick were recognized for their academic work and passion for marketing. Both students also received other top recognitions in marketing, providing them the opportunity to present at industry conferences, meet other student leaders, and dive into their future field.

### **Kean Professors Develop Training Program to Work with Autistic Children**

Two Kean University speech-language pathology professors have received a faculty scholarship to develop a model graduate-level training program for students to specialize in working with children on the autism spectrum.

Over the next year, Mahchid Namazi, Ph.D., and JoAnne Cascia, Ed.D., will create a 12-credit course, Interprofessional Specialization in ASD (Autism Spectrum Disorder), for Kean students in the speech-language pathology and clinical-school psychology (Psy.D.) programs to prepare them for both conducting research and providing direct care to patients.

### **Kean Graduate Spreads the Word About Climate Change at United Nations Forum**

Kean alumnus Michael Favetta '07 has built a successful career around the weather. Hired as an on-air TV meteorologist while still a Kean student, he later founded a meteorological consulting firm, WeatherPrep, and co-founded the international group Climate Without Borders, which works to create broad public support for climate action.

Favetta presented on the topic “Communicating Climate Change” at the 2019 United Nations Framework Convention on Climate Change NGO Forum in Taipei, Taiwan.

### **Kean Hosts Google Women in Computing Event**

When the Kean School of Computer Science and Technology wanted to encourage young women from across the region to pursue careers in computer science research, it turned to one of its own: alumna Yerika Jiménez.

Jiménez '14, who is pursuing a doctoral degree in human-centered computing at the University of Florida, was the keynote speaker at Kean's Exploring Research: Women in Computing conference, held at Kean. The conference, sponsored by Google and other organizations, was designed to introduce undergraduate students, particularly women, to research opportunities in computer science and information technology.

### **Virtual Research Days Event Features Alumnus Guest Speaker, Wider Online Audience**

David Garcia '14, a Kean university graduate who overcame a rare physical disability to win a National Institutes of Health fellowship, shared his inspirational story at Kean's first-ever Virtual Research Days event held on April 28, 2020. Garcia, who received a degree in chemistry and biology from Kean, was born with Moebius Syndrome, a neurological condition that gave him partial upper limbs, missing fingers, and no feet. He shared his successes and struggles, and encouraged people to be relentless in the pursuit of their dreams.

Previously, Garcia did extensive research with Kean's McNair Scholars, Research Days, and other programs, and will serve as special guest speaker when Kean's annual symposium goes live online.

### Patricia Galeski

These are the words of Patricia Galeski – a New Jersey native and the newest member of the Kean University Foundation's Medallion Society. Born in Jersey City, Patricia is the oldest child of two deaf parents, neither of whom graduated high school and spent their adult lives as unskilled laborers. These circumstances created some of her earliest memories, with her acting as translator for both parents while accompanying them on frequent trips to the unemployment office. Given their limited skills and lack of training, Patricia's parents often found themselves out of work during periods of economic downturns throughout the 1950's.

Such experiences instilled in Patricia a great desire to obtain a college degree. She knew her parents would be unable to support her goal financially, but saw the value in pursuing higher education and set her sights on achieving academic excellence in an effort to earn a scholarship. "From second grade on," said Patricia, "I promised myself I would be going to college."

Patricia's family eventually moved to the suburban town of Morganville, New Jersey, where she attended Freehold High School and was classmate to a little-known (at the time!) guitarist by the name of Bruce Springsteen. There, she maintained her studies and remained focused on the promise she had made to herself many years earlier. Patricia completed the SAT exam, as well as an additional test administered by the State of New Jersey. She performed very well, and her scores resulted in Patricia being awarded a full scholarship to Newark State Teachers College – which had just relocated from Newark to Union.

When Patricia's acceptance letter arrived in the mail, her father was quite clear and told her, "You are not going to college; you should be a secretary, a teacher, or a nurse. As a matter of fact, this scholarship would be better suited for a man and, most importantly, we need you to work as your salary pays for room and board in our house." For several years thereafter, Patricia worked for IBM in various locations, including Holmdel, NJ, Baltimore, MD, and Atlanta, GA. She initially performed secretarial and administrative work before being promoted to Systems Engineer and eventually moving into a sales role. IBM recognized Patricia's talents and she found success there.

In 1992, the recession caught up with Patricia and she, like many others at the time, found herself out of work and unable to gain new employment without a college degree. She eventually acquired a position within the School of Nursing at the University of Maryland in Baltimore, where she worked for a period of time before further economic downturns resulted in unemployment yet again.

One day, Patricia received a letter in the mail from the Governor of Maryland. This letter stated, as a result of having been downsized twice from her places of employment, Patricia was eligible to receive a Pell Grant affording her the ability to attend college. At last, Patricia would be able to earn the college degree she had longed for ever since childhood – and she did just that! A woman already in her 50's, she went on to earn a Bachelor of Science Degree in Business Administration from the University of Maryland, having achieved a 3.5 GPA and subsequently graduating with honors.

Patricia eventually settled in Durham, North Carolina, where, in light of the recent onset of the COVID-19 pandemic, she has taken the opportunity to reflect on her legacy. She realized how different her life would have been had she attended Newark State Teachers College, and decided she wanted to provide the same opportunity she was given to another young woman. This realization resulted in Patricia making a bequest, or a written provision in her will allowing for a gift from her estate to the Kean University Foundation shortly after her passing, to establish an Endowed Scholarship – and thusly earning her membership within the Foundation's Medallion Society.

You have also lightened my financial burden allowing me to focus on the most important aspect of school – learning."

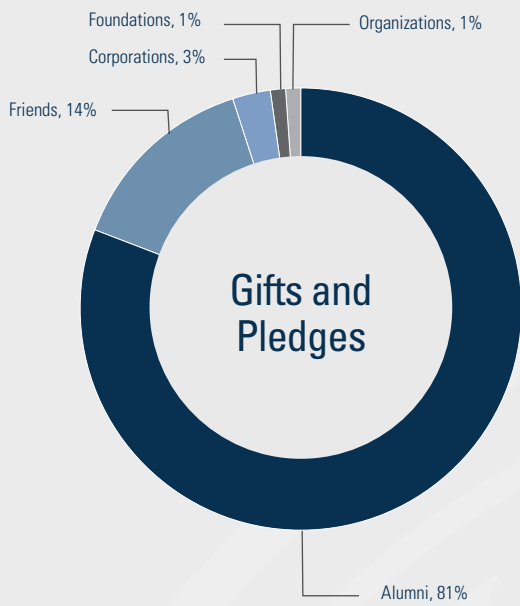

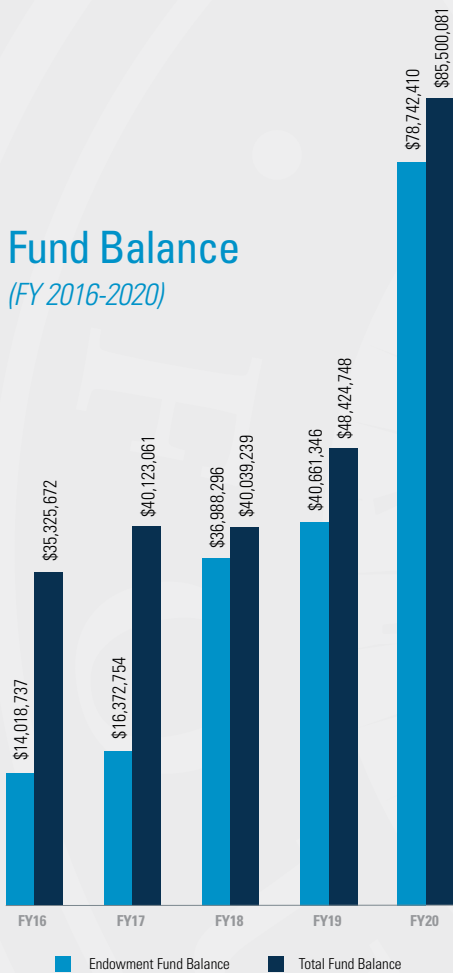

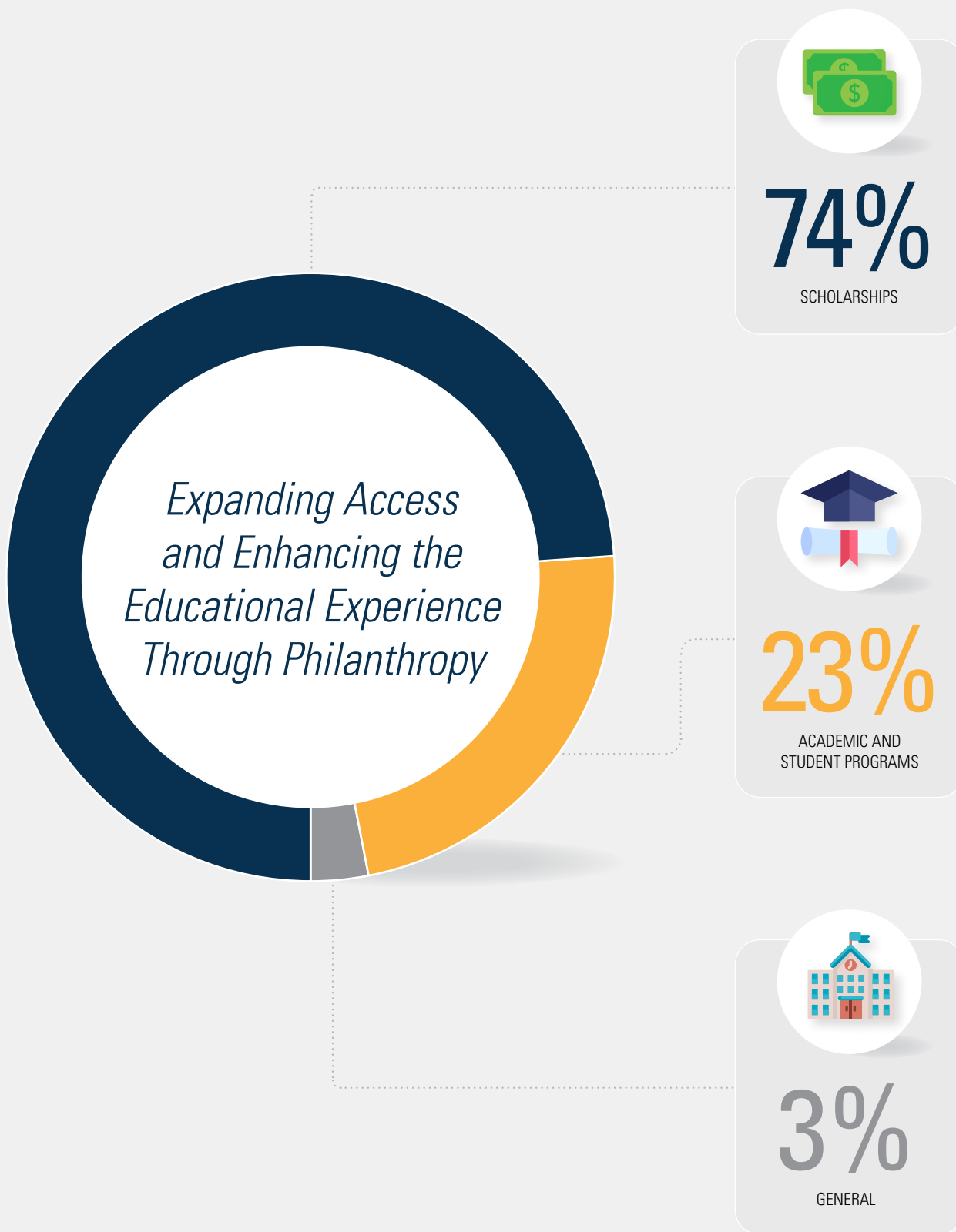
